Company may require every member to disclose BO

Guidelines on BO Reporting

Only those holding 20% interest or more or those who control



COMPANY - BO Reporting Obligation



New companies (Prior to the obligation to submit the first annual return)
Starts after company secretary appointed

To obtain the BO information within 30 days after the appointment of a company secretary.


To enter the BO information into the Register of BO within 60 days after the BO information has been obtained or received.

To notify the Registrar within 14 days from the date the BO information is entered into the Register of BO (* SSM will advise of Submission Channel of notification later on)

To lodge annual return together with the "Annexure – Particulars of BO" not later than 30 days from the anniversary of its incorporation date.



COMPANY - BO Reporting Obligation



Existing companies (Commencing from obligation to submit first annual return and subsequently)
Starts from
I March 2020

To notify the Registrar of the changes in the Register of Members within 14 days from the date the BO information is recorded in the Register of BO. (* SSM will advise of Submission Channel of notification later on)

To lodge annual return together with the "Annexure – Particulars of BO" not later than 30 days from the anniversary of its incorporation date.

COMPANY - BO Identification



GUIDELINES REQUIREMENTS

Company has a duty to <u>identify</u>, obtain and verify the BO information and to keep the BO information together with the supporting documents relating to the BO information.

- Consider interests in the company held by individual, corporate entities and/or trust.
- If corporate shareholder then, identify the individuals controlling the corporate shareholder.
- Review all documents and information available at the company (eg Register of Members, trust deed, shareholders agreement, Constitution)
- Consider any evidence that may show interests or rights held through a variety of means that may ultimately be controlled by the same person, e.g. joint arrangement, control of Board/Board decision

COMPANY - BO Identification



Identified BO	Has interest, direct or indirectly, in not less than 20% of the shares
	Hold, directly or indirectly, not less than 20% of the voting shares of the Company
Potential BO	Has the right to exercise ultimate effective control whether formal or informal over the company; or the directors or the management of the company
	Has the right or power to directly or indirectly appoint or remove a director(s) who hold a majority of the voting rights at meeting of directors
	Is a member of the company and, under an agreement with another member of the company, controls alone a majority of the voting right in the company

COMPANY – Obtain BO Info



GUIDELINES REQUIREMENTS

Company has a duty to identify, <u>obtain</u> and verify the BO information and to keep the BO information together with the supporting documents relating to the BO information.

- Company to send s56 notification to identified BO or potential BO to seek confirmation.
- When there are changes in shareholders or shareholding, Company is to send s56 notification to seek confirmation of BO.
- Annually send s56 notification to re-confirm the BO information before filing of Annual Return

COMPANY - BO Verification



GUIDELINES REQUIREMENTS

Company has a duty to identify, obtain and verify the BO information and to keep the BO information together with the supporting documents relating to the BO information.

- A company secretary is obliged to conduct verification when:
 - (a) the obligation arises to enter the name of a BO in the Register of BO
 - from I March 2020
 - Within 30 days from first appointment as company secretary
 - > from date of changes entered in the Register of Members
 - (b) when an obligation arises to enter the changes to the particulars of BO information in the Register of BO
 - on receipt of notification from BO or nominee of changes
 - > on annual BO verification for Annual Return submission

COMPANY - Register of BO



- Company has a duty to identify, obtain and verify the BO information and to keep the BO information together with the supporting documents (i.e. the replies received from Nominee/BO)_relating to the BO information.
- Only the <u>verified</u> BO information (i.e. when BO has replied with confirmation) can be entered into the Register of BO.
- Register of Beneficial Owner <u>cannot be empty</u>. Even if the BO does not reply, the information on the name of registered member and date of s56 notice sent to him is entered into the Register of BO.

ASSESS TO REGISTER OF BO



- Company can only grant access of BO information to competent authorities (Auditors are not authorities), law enforcement agencies, the BO whose name has been entered in the Register of BO and any other person authorised by the BO.
- ❖ BO shall only be given access to the BO information relating to him (BO A can only view BO A's info and he cannot view BO B's info. Therefore a Register of BO is kept for each BO separately).
- Copies of the BO information shall be provided on request (in writing) of the competent authorities, law enforcement agencies, the BO whose name has been entered in the Register of BO and any other person authorised by the BO.

PLACE WHERE REG. OF BO TO BE KEPT



BO information and supporting documents to be kept at the registered office or where the register of members is being kept.

RO – Place A Register of BO kept at Place A	No filing to SSM
RO – Place A and ROM – Place B Register of BO kept at Place B	To file S47(2) to SSM within 14 days
RO – Place A and ROM – Place B Register of BO kept at Place C	Not allowed

*BO information and supporting documents must be kept for at least 7 years from the date a person ceases to be a BO

- SC licensed companies
- Public Listed companies
- Public Un-Listed companies where shares still in central depository





RESOLVED THAT the Policy on Beneficial Ownership Reporting, requiring shareholders of the Company to notify the Company on the identity of the beneficial ownership and when there are changes in the beneficial ownership information, as attached be adopted.

THAT a Meeting of Members be convened at (venue) on (date) at (time) for the Members to consider the Special Resolution to approve the amendment to the Constitution of the Company as follows:........

SAMPLE ARTICLE IN CONSTITUTION



INFORMATION OF SHAREHOLDING

- (i) The Company may require any information of a Member
 The Company may by notice in writing require any Member
 within such reasonable time as is specified in the notice:-
 - (a) to inform the Company whether he holds any voting shares in the Company as beneficial owner or as trustee; and
 - (b) if he holds them as trustee, to indicate so far as he can the persons for whom he holds them by name and by other particulars sufficient to enable those persons to be identified and the nature of their interest.

SAMPLE ARTICLE IN CONSTITUTION



INFORMATION OF SHAREHOLDING (continued)

(ii) Company may require any information of beneficial interest

Where the Company is informed in pursuance of a notice given to any person under Article (i) hereof or this Article that any other person has an interest in any of the voting shares in the Company, the Company may by notice in writing require that other person within such reasonable time as is specified in the notice:-

- (a) to inform the Company whether he holds that interest as beneficial owner or as trustee; and
- (b) if he holds the interest as trustee, to indicate so far as he can the persons for whom he holds such interest by name and by other particulars sufficient to enable them to be identified and the nature of their interest.

INFORMATION OF SHAREHOLDING (continued)

(iii) The Company may by notice in writing require a Member to inform the Company, within such reasonable time as is specified in the notice, whether any of the voting rights carried by any voting shares in the Company held by him are the subject of an agreement or arrangement under which another person is entitled to control his exercise of those rights and, if so, to give particulars of the agreement or arrangement and the parties to such agreement or arrangement.

BOARD RESOLUTION – Invoke s56



RESOLVED THAT in accordance with the Guideline for the Reporting Framework for Beneficial ownership of Legal Persons issued by the Companies Commission of Malaysia on I March 2020, the Company shall invoke section 56 of the Companies Act 2016 ("Act") and shall authorise the Company Secretary to send out the notices pursuant to subsection 56(1), (2) or (3) of the Act to the identified beneficial owners.

THAT the Company Secretary be further authorised to send out the notices under subsection 56(I) in the month of _____ every calendar year for the purposes of updating the beneficial ownership information for the submission of the Annual Return of the Company.

CRITERIA OF BO



Α	Has interest, direct or indirectly, in not less than 20% of the shares (includes both voting and non-voting shares);
В	Hold, directly or indirectly, not less than 20% of the voting shares of the Company (voting shares only);
С	Has the right to exercise ultimate effective control whether formal or informal over the company; or the directors or the management of the company (decision maker on running of the business of the company);
D	Has the right or power to directly or indirectly appoint or remove a director(s) who hold a majority of the voting rights at meeting of directors (founder is no longer a member or director but his recommendations are always followed by the Board); or
E	Is a member of the company and, under an agreement with another member of the company, controls alone a majority of the voting right in the company (joint arrangement).
